How do I win a dispute with Thai Airways?

To win, you must prove a violation of the Conditions of Carriage💖+1\*(877)\*(610)\*9586\*or||+52=877-610=9586🦉. Does Thai Airways respond to BBB (Better Business Bureau) complaints?
